The student will be required to PASS in Continuous Evaluation and End Semester Exam evaluation separately.

RE-DO Examination

- The students will be provided only two chances to reappear in any subject to clear End Semester Examination during the approved Maximum Duration of the concerned program.
- 100 Marks paper may be conducted for re-do
- For the first chance students will be charged Rs. 500/- for the redo examination. For the subsequent chances to reappear in the same subject students are required to submit two times the prescribed fee for second chance.
- Re-do examination for all subjects offered in odd semester i.e. 1, 3, 5, 7 & 9 will be conducted as per the date sheet of the concerned semester & Re-do examination for even semester i.e. 2, 4, 6, 8 & 10 will be conducted as per the date sheet of the concerned semester.
- A student will be given two chances for Re-Do exam for a particular subject to qualify in the said subject. Even if he/she does not clear the subject (S) in two re-dos he/she will be marked as "Not Fit for Trade" and would be asked to leave the course.
